## **Courtesy Card Application**

The County Express Courtesy Card entitles the cardholder to receive a discount on County Express bus passes and tokens. The Card only indicates that the cardholder qualifies for the discount fare based on age and/or a disability. It <u>does not</u> mean the cardholder is eligible for Paratransit service. Eligibility determination and notification will occur within 7 to 10 business days. Upon expiration, cardholders are required to submit a new application form for recertification. *Information submitted for the Courtesy Card will be kept strictly confidential.*

- A. Fill out Part 2, 3, and 4 completely.
- B. Submit the completed application, a photo ID, and acceptable documents (listed in Part 3) verifying your eligibility <u>in-person</u> to the Local Transportation Authority Office at 330 Tres Pinos Road, Suite C7 in Hollister, California. Incomplete or mailed applications will not be processed. If you have any questions, call the Local Transportation Authority at 831.637.7665.
- C. If your eligibility category requires a note from your physician or caseworker, you must obtain the note <u>before</u> submitting the application. The documentation must be submitted at the same time of the application.
